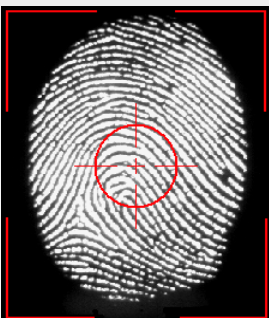


### BACKGROUND CHECKS
